Welcome to Jungle Gym, LLC your Indoor Inflatable Party and Jump Center, where we strive to provide a safe, clean, and fun atmosphere. In consideration of my child(ren) and myself participating in all of the inflatable fun located inside, I acknowledge and agree on behalf of myself and my child(ren) identified above that:

1. The risk of serious injury from participating in Jungle Gym's activities, although minimal, does exist and includes the potential for permanent paralysis and/or death; and
2. I and my child(ren) are physically fit to participate in all activities at Jungle Gym and I agree to attend to and monitor the activities of my child(ren) such that all activities are appropriate for my child(ren); and
3. I, for myself and my child(ren), knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of Jungle Gym, LLC or others, and assume full responsibility for my and my child(ren)'s participation at Jungle Gym; and
4. I and my child willingly agree to comply with the stated terms and conditions for participation and to obey the directions and requests of Jungle Gym, LLC staff. If I observe any hazards during my presence or participation, I will remove myself and my child from the participation and bring said hazard to the attention of the nearest Jungle Gym employee or official immediately; and
5. I, for myself, my child and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY WAIVE, RELEASE, AND HOLD HARMLESS Jungle Gym, LLC and its officers, agents, employees, and other participants (collectively, the "Jungle Gym Family") with respect to any and all claims for personal injury, disability, death, or loss or damage to person or property, even if arising from the negligence of the Jungle Gym Family or otherwise; and
6. This release and waiver extends to all acts of negligence by the Jungle Gym Family and is intended to be as broad and inclusive as permitted by the laws of the State of Virginia, and if any portion of the agreement is held invalid, it is agreed that the balance shall, not with standing, continue in full legal force and effect.

I RELEASE AND AGREE TO HOLD HARMLESS AND INDEMNIFY JUNGLE GYM, LLC PARTY AND JUMP CENTER FROM ANY AND ALL LIABILITIES INCIDENT TO MY MINOR CHILD(REN)'S INVOLVEMENT OR PARTICIPATION IN JUNGLE GYM'S ACTIVITIES, INCLUDING SUCH LOSS, LIABILITY, DAMAGE OR COST (INCLUDING ATTORNEY FEES) EVEN IF SUCH ACTION ARISES FROM THE NEGLIGENCE OF THE JUNGLE GYM FAMILY TO THE FULLEST EXTENT PERMITTED BY LAW.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS FOR MYSELF AND MY CHILD(REN) BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT.
